



16. STIKEMAN, ELLIOTT

The law firm is divided into broadly defined practice groups which include Corporate/Commercial, Energy, Environment, Financial Services, Power, Taxation and Trade. The Honourable Marc Lalonde sits on the Advisory Board of Western Advisors to the Government of Ukraine.

The Seagram Company Ltd. is a leading global producer and marketer of distilled spirits, wines, fruit juices, coolers and mixers, and sells brands in more than 150 countries. Recent changes in Europe have opened the doors to Ukraine, and Seagram has been an industry leader in establishing both a distribution arm and a manufacturing base there.

24. UK-RAN OIL CORPORATION

UK-RAN Oil Corporation is setting up operations in Ukraine. The Calgary-based company has been working on an oil field servicing project for the past 18 months. Production is anticipated before the end of the year.

25. MAGNA INTERNATIONAL INC.

Magna International Inc. is one of the world's largest auto parts manufacturing companies with some 67 facilities operating in Canada, the United States, Germany and Austria, and annual sales of over \$2 billion. Magna has been operating in Ukraine since 1989 in a joint venture with Ukraine's largest automobile manufacturing company, Autozaz, in Zaporizhia.

26. ALCAN INTERNATIONAL LIMITED

Alcan International Limited is a wholly owned subsidiary of Alcan Aluminum Limited. Alcan Aluminum Limited is an integrated aluminum company with operations and properties in Canada, the United States, Europe, South America and the Pacific. The company is engaged in bauxite mining, alumina refining, aluminum smelting, fabricating and recycling. It sells its products to the packaging, construction, transportation and other industries in Canada, the US and around the world.

27. NORTHLAND POWER

together with the Ministry of Energy in Ukraine is pursuing the reconstruction and expansion of the Darnycka (Kyiv) District Heat and Power Plant.

28. THE FRASER INSTITUTE

The Fraser Institute is an economic think tank which publishes books and periodicals dealing with economic policy in Canada and in other countries.
